Bracco UK Ltd is committed to achieving net zero emissions by 2045 when we plan to have reduced our emissions by 90%.



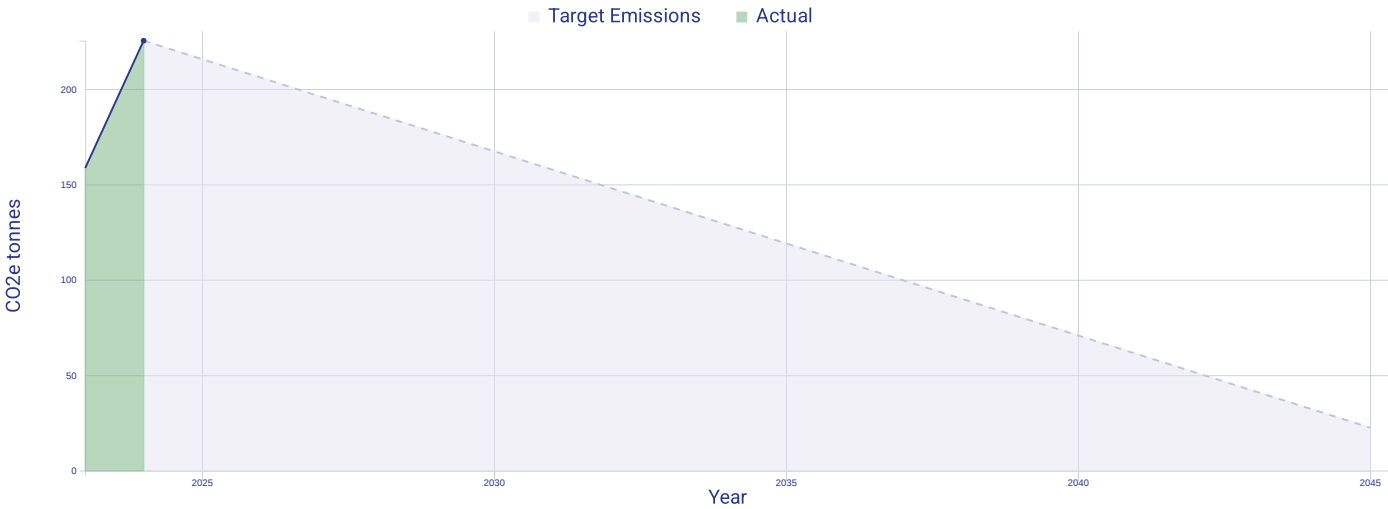
# Baseline Emissions Footprint vs Current Emissions Footprint

Achieve measurable reduction in business travel emissions relative to employee headcount through enhanced journey efficiency and sustainable transport adoption.

**Action, Improvement or Control**

Develop smart travel solutions through route optimisation, geographical meeting consolidation, virtual meeting adoption where appropriate. Also encourage staff to purchase and or transition to hybrid/electric vehicles.

### Transportation - Receiving and delivery of goods

Use the lowest impact transport method available

**Target**

Reduce emissions from upstream and downstream transportation and distribution.

**Action, Improvement or Control**

Have conversations with suppliers to advise that we are looking to reduce emissions from transport, as such they should prioritise transporting our products using the lowest emission vehicles available to them.

As we grow as a business we are going to ensure we have robust policies around sustainability. This includes implementing sustainable travel and purchasing policies.
